VOLENTEER ROLES

BOARD OF DIRECTORS

Board Members should be upstanding members of society who can add value to the organization & conduct themselves in a professional manner. The Board of directors has full and final authority over the affairs of the organization. Responsibilities include (but are not limited to) voting on yearly agenda, bylaws, budgets, salaries, projects, allocating grant funds over the amount of \$1,000 & monitoring general progress and goals throughout the year. They will be encouraged to participate in a minimum of one community event during the year and to assist with fundraising where possible. Meetings will be held quarterly on the 2nd Wednesday of January, April, July & October unless otherwise specified or circumstances do not allow. Board Members may assume the role of general members, Executive Director or Standing Executive Committee members. Upon approval of a board position, all members are required to read "Board Member Orientation" and sign a code of conduct agreement.

Anticipated time commitment: less than 1 hour/month

STANDING EXECUTIVE COMMITTEE

This branch is the heart of the organization. They are responsible for project planning and development, fundraising, volunteering, goal setting and community relations. Any Lifetime Member is eligible to apply to join the Standing Executive Committee. In-person meetings will be held 2nd Tuesday of every month.

Anticipated time commitment - average of 6 hr/month

COMMUNITY MEMBERS

Community Members are members of the community who would like to be a part of the organization on a no-commitment basis. They will be first point of contact when volunteer opportunities become available. They will have priority when considered for micro grants. Yearly fees are \$30 per member or \$100 Lifetime Membership. Yearly dues sponsorship is available for members who actively serve in volunteer roles 10+hours/yr. Members are welcome to voice concerns and suggestions at the annual Community Members meeting but do not have voting rights. They may be "poled" on certain concerns. Community Membership will be open to submit applications from February 1st through April 1st. Membership will be approved by Standing Executive Committee at their April meeting. First community meeting will take place 1/10/2026 and will be open to any women interested in joining

BOARD ROLES & RESPONSIBILITIES

President:

Oversees board meetings
Ensures the board fulfills its governance duties

Vice President:

Supports the President and leads committees as needed Steps in to facilitate meetings or initiatives when the President is unavailable

Treasurer:

Reviews financial statements and budget reports Ensures fiscal health and legal compliance

Secretary:

Records and distributes meeting minutes

Maintains governance records

Chairpersons:

Participate in board votes and strategic discussions

Serve on a committee

Support the board in furthering our mission

Take on additional responsibilities as the organization grows

Executive Director:

Responsible for day-to-day workings of the organization
Reports to the board and oversees the standing Executive Committee
Representing the organization as the face of the program

*All board positions are a 3 year term with option to renew. Executive Director position is permanent unless otherwise decided by them or the board
